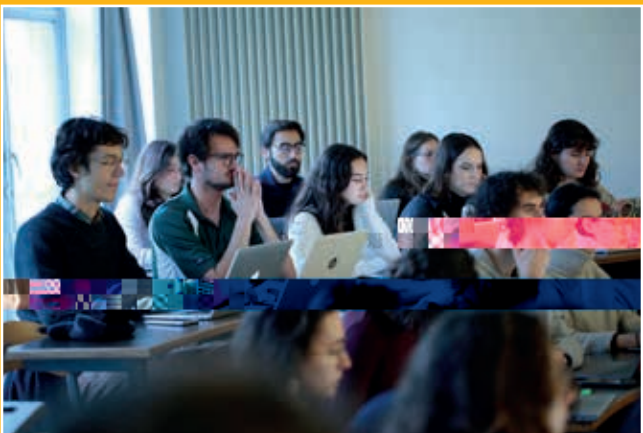

# ACCOMMODATION

## On-Campus Student Accommodation

All participants have the opportunity to reserve housing in the HEC Paris Residence, a step away from the classroom. Summer School participants are housed in single room accommodation, including a desk for personal study, a private bathroom and shower. The kitchenette is equipped with a fridge, double hotplate, microwave oven and sink.

Housing on campus is not mandatory. However, participants are encouraged to reside on campus to benefit from campus life and the program experience. On-campus accommodation fees: 390€ for 1 session, 680€ for 2 sessions.

The application process is simple and straightforward. You will need to provide your academic CV, a 500-word personal statement, and a letter of recommendation (if applicable).

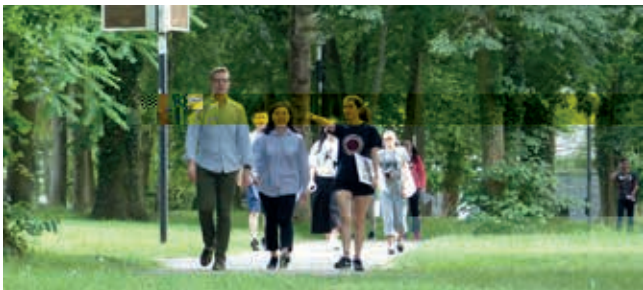

# FEES

## Program fees include:
